1- 70% of SJMS students will be proficient in their content knowledge in each course based on the four-point rubric and state standards. 2- 100% of SJMS faculty will have additional Standards Based Grading (SBG) training in 2021-22 and implement aspects the district SBG Committee agrees upon to be able to increase student learning. 3- Teachers' grading scale will be on 80% assessment, with retakes allowed to show learning improvements, and 20% assignments to demonstrate the learning.

Due to a district-wide initiative of Standards Based Grading and the desire to improve student learning, South Jordan Middle School staff will participate in extensive training over a three to five year period to understand and impelement the research-based practice. It has been proven that SBG is a technique which is in the students' best interest for learning. Proficiency scales are created and used to demonstrate what it is that the students need to konw related to each standard. Teachers need support and training to be able to create effective and meaningful Proficiency scales in addition to Assessments tied to them. The Proficiency scales will be in the students' hands to be able to identify what they know and need to know in each course at SJMS.
